How can 2025 annual statements be viewed online?

1. ANZ Internet Banking

Log in to ANZ Internet Banking at **anz.com.au** using your ANZ Customer Registration Number (CRN) and password. Select your ANZ Smart Choice Super account, go to 'Manage my account' and then select 'Communications' from the menu.

If your account does not appear in ANZ Internet Banking, you may request to have your account linked to your ANZ Internet Banking:

- Once logged in, go to Settings > Link / delink personal account
- enter your ANZ Smart Choice Super member number (15 digits) in the Account number field
- for required access, select 'Link account' and choose 'All Transactions' in the dropdown

Alternatively, you may register for access via ANZ Smart Choice Super online access.

2. ANZ Smart Choice Super online access

Go to **www.anz.com.au/smartchoiceaccess** and Register (if you haven't previously) or Log in to my super account (if you've already registered via this page).

Registering for online access only takes a minute or two, and you'll need your ANZ Smart Choice Super member number (15 digits) and access to your email account.

Once logged in, go to 'Manage my account' and then select 'Communications' from the menu.

Please note that statements for ANZ Smart Choice Super Defined Benefit are not available online.

When will you receive your 2025 annual statements?

When your annual statement is ready, we'll send you an email or SMS to notify you that your annual statement is ready to view online. Please note that you will not receive a mailed copy of your annual statement unless you have opt-out of electronic communications. Annual statements will be progressively mailed from August through to September.
